Special scholarships for students in doctoral degree programmes in a foreign language in the academic year 2020/2021

Content: The Norm specifies the rules for awarding a special scholarship to students in

doctoral degree programmes delivered in a foreign language at the Faculty of Education, Palacký University Olomouc in the academic year 2020/2021.

Special scholarships for students in doctoral degree programmes in a foreign language in the academic year 2020/2021

Article 1 Introductory Provisions

Following Section 91, Sub-section, 2, Clause b) of Act No. 111/1998 Coll. on higher education institutions and on amendment to some acts (Act on Higher Education Institutions) as last amended (referred to as the "Act on Higher Education Institutions"), pursuant to Article 7 of the Scholarship Code of Palacký University Olomouc, Internal Regulation of Palacký University Olomouc R-A-18/01-ÚZ01, and pursuant to Article 5, Clause 1) of the Scholarship Code of the Faculty of Education, Palacký University Olomouc, and Internal Norm of the Faculty of Education, Palacký University Olomouc PdF-B-18/17, I hereby determine the conditions for the payment of the special scholarship to students in doctoral degree programmes accredited in a foreign language delivered by the Faculty of Education, Palacký University Olomouc (referred to as PdF UP) in the academic year 2020/2021.

Article 2 Scholarship for outstanding publication activity

1. The scholarship for outstanding publication activity is intended for all students who have published in the capacity of the first, lead, or corresponding author a paper in a journal with a non-zero AIS (Article Influence Score) value or SJR (SCImago Journal Rank) value. The applicant's

- publication activity shall be demonstrated by submitting the following bibliographic data: title of the paper, names of all authors, full name of the periodical (series, volume, year, number, page), and ISSN. publication may also be confirmed by submitting an official confirmation of acceptance of the paper for issue.
- 2. The applicants for scholarship shall submit a written scholarship application to the Office of Doctoral Studies (referred to as the "Doctoral Office") based on an assessment and recommendation by the Supervisor, Chairperson of the Subject Area Board, and Vice-Dean for Science, Research, and Doctoral Studies.
- 3. The amount of the scholarship for a single paper in a journal with a non-zero AIS or SJR value shall be 10,000 CZK. For each paper the scholarship shall be paid only once.
- 4. The scholarship shall be paid by means of bank transfer to the student's bank account with a bank in the territory of the Czech Republic in Czech crowns.

Article 3 Scholarship for activities beyond the individual study plan

1. The scholarship for activities beyond the individual study plan is intended for all students for outstanding activities performed in favour of the Faculty, University, and Academia, particularly including participation in promotion activities of the Faculty, participation in

- educational and social activities of the Faculty, etc.
- 2. The Dean shall decide on awarding the scholarship based on the proposal of the Vice-Dean, Head of Department, Chairperson of the Subject Area Board, or Supervisor.
- 3. The scholarship for these activities may be paid repeatedly.
- 4. The scholarship shall be paid by means of bank transfer to the student's bank account with a bank in the territory of the Czech Republic in Czech crowns.

Article 4 Final Provisions

- 1. This Internal Norm shall come into force and effect on the date of issue.
- 2. This Internal Norm shall become void once its purpose has been fulfilled.
